I wish to participate and provide volunteer services to the Club and Association, and I understand that my relationship with the Club and Association is limited to a purely voluntary club membership and volunteer position and that I am not entitled to any wages or other compensation in return for providing the volunteer services.
- 2. I am not entitled to receive unemployment insurance benefits, disability insurance benefits, pension benefits, health insurance benefits, or any other employment-related benefit on account of my volunteer service for the Club and Association, and I understand that the Club and Association is entitled, in its sole discretion, to terminate my services and/or this Agreement at any time, with or without notice, and with or without cause.
- 3. I understand that the Volunteer Services and the Club Activities may include activities involving inherent and other risks, known and unknown, to my personal safety and property which could result in my injury, death or other damage, and I hereby certify (i) that I am qualified, in good health, and in proper physical condition to perform the Volunteer Services and to participate in the Club Activities; (ii) that I have no medical conditions or allergies that affect my ability to perform the Volunteer Services or to participate in the Club Activities; and (iii) that I will not be under the influence of alcohol or any illicit or prescription drugs during the Club Activities which would in any way impair my ability to safely perform the Volunteer Services or to participate in the Club Activities.
